



## AB Announces February 28, 2018 Assets Under Management

NEW YORK, March 12, 2018 /PRNewswire/ -- AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management decreased to \$555 billion during February 2018 from \$569 billion at the end of January. The 2.5% decline was predominantly due to market depreciation, though firmwide net outflows contributed as well. By channel, net outflows from Retail and Institutions were partly offset by net inflows to Private Wealth.
