



## AB Announces December 31, 2016 Assets Under Management

January 11, 2017

NEW YORK, Jan. 11, 2017 /PRNewswire/ -- AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management increased to \$480 billion during December 2016 from \$478 billion at the end of November. The 0.4% increase was driven by market appreciation, which offset firmwide net outflows and the negative impact of currency fluctuations. By channel, outflows from Retail and Private Wealth more than offset net inflows to Institutions.
