AB Announces December 31, 2021 Assets Under Management

Nashville, TN, January 11, 2022 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management increased to \$779 billion during December 2021 from \$759 billion at the end of November. Market appreciation and firmwide net inflows drove the 3% increase. All channels reflected positive net flows in the month of December, led by Institutional and Retail.
