### AB Announces March 31, 2022 Assets Under Management

Nashville, TN, April 11, 2022 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management decreased to \$735 billion during March 2022 from \$740 billion at the end of February. The 0.7% decrease was due to market depreciation and firm-wide net outflows. By channel, Private Wealth generated positive net flows while Institutional and Retail posted net outflows.
