AB Announces July 31, 2023 Assets Under Management

Nashville, TN, August 10, 2023 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management increased to \$704 billion during July 2023 from \$692 billion at the end of June. The 2% increase was driven by market appreciation, offset by firmwide net outflows. By channel, Institutions experienced net outflows, Private Wealth generated modest net inflows, and Retail net flows were flat.
