AB Announces March 31, 2024 Assets Under Management

Nashville, TN, April 9, 2024 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management increased to \$759 billion during March 2024 from \$746 billion at the end of February. The 2% increase in month-end AUM was driven by market appreciation, partially offset by net outflows. Excluding a \$3.0 billion low-fee passive institutional redemption, firm-wide net flows were positive for the month of March, and were positive in each channel.
