#### AB Announces February 29, 2024 Assets Under Management

Nashville, TN, March 11, 2024 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management increased to \$745 billion during February 2024 from \$726 billion at the end of January. The 3% increase in month-end AUM was driven by market appreciation coupled with positive net flows across all channels, led by Retail.
