Nashville, TN, December 11, 2023 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management increased to \$696 billion during November 2023 from \$652 billion at the end of October. The 6.7% AUM increase was due to market appreciation and firmwide net inflows into all three distribution channels - Retail, Institutions and Private Wealth.
