AB Announces September 30, 2023 Assets Under Management

Nashville, TN, October 10, 2023 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management decreased to \$669 billion during September 2023 from \$694 billion at the end of August. The 4% AUM decrease was primarily due to market depreciation, alongside net outflows. By channel, Retail net inflows were offset primarily by Institutional net outflows and modest Private Wealth net outflows.
