## AB Announces January 31, 2024 Assets Under Management

Nashville, TN, February 12, 2024 - AllianceBernstein L.P. ("AB") and AllianceBernstein Holding L.P. ("AB Holding") (NYSE: AB) today announced that preliminary assets under management increased to \$726 billion during January 2024 from \$725 billion at the end of December. January AUM reflected market gains, partially offset by net outflows. By channel, net inflows to Retail were offset by net outflows from Institutions and Private Wealth.
